New membership is considered as being temporary for a period of three months or until ratified by the Board. Should your membership not be ratified then your subscription fee only will be refunded.

Data Protection Statement:-

1. In order to function effectively as an Association, PISC needs to record the following information from each member:-
 - a) First name and family name
 - b) Area of residence (i.e. Kato Paphos, Tala etc.)
 - c) email address
 - d) Telephone number
2. It will not be possible for anyone to become a member of PISC without disclosing the required information above.
3. This information is stored electronically by the Membership Secretary on his/her personal device/s. He/she may also keep paper copies in his/her possession.
4. Paper printouts of this information are made and used in the normal routine of running the affairs of the Association. E.g. membership registration list at AGM or EGM.
5. This information may be shared with other Board members or officers of the Association for similar routine running of the affairs of the Association. E.g. Social functions, fundraising etc.
6. Names, email address and Telephone number are published in the form of a directory on the website in the restricted members' area, **ONLY** of those members who have expressly agreed to this. (Email addresses are encoded to help prevent attack from spambots.)
7. This information may be shared with our parent sporting bodies (such as Cysaf) in the normal routine running of the affairs of the Association.
8. From time to time press releases are compiled and distributed to various media outlets, which may contain images of members together with their names and/or titles, for the purpose of promoting the activities of PISC and sailing in general.
9. We also periodically send out notices of AGM's and EGM's as well as a weekly newsletter via a third-party encrypted mailing service (Mailchimp) using your name and email address.

PISC takes the protection of members' personal information very seriously and will not knowingly allow your information to be used by any commercial enterprises or dealers in data. PISC will not knowingly disclose your information to anyone outside of the Association other than in the manner outlined above. Members who abuse their access to your information will be severely dealt with.

Despite our best efforts, PISC CANNOT guarantee that your information as provided above will not find its way into the public domain.

Your information will be deleted permanently from all databases upon the termination of your membership of the Association.
