First Aid & Fire Appliances (FAFA) are provided in the kitchen and by all exits. There are various sliding patio door exits from the Clubroom. The exits and FAFA are inspected on a quarterly basis by the Health & Safety Officer and the Fire Extinguishers are inspected monthly by the Rear Commodore House. The Fire extinguishers are maintained yearly by a registered company arranged by the Rear Commodore House.	1	5	5
